

- The Industries Commissionerate functions under the Industries & Mines Department of Government of Gujarat and implements industrial Policies of the state and central Governments. The prime responsibility of IC office is to observe and proactively act as a catalyst in industrial development and bringing about industrial reforms.
- In each district one agency to deal with all requirements of MSME Industries (up to 10 Cr). This is called "District Industries Centre"

SHRI VAJPAYEE BANKABLE YOJANA

State Government Scheme

All three Sectors i.e. Industries, Business/Trade and Services can take benefit of this scheme

Purpose: This scheme aims to supply selfemployment to the unemployed persons in urban and rural areas.

Eligibility Criteria of the Scheme:

- Age: 18 to 65 Years.
- Qualification: The applicant should have passed minimum standard fourth <u>OR</u>,
- **Training/ Experience:** Should have undergone training for minimum three months from private establishment or minimum one month from Government recognized Institutes, in the area of the proposed business or should have experience of minimum 1 year in the same activity or should be hereditary craftsperson.
- No Income criteria.

Maximum Limit for Bank Loan:

- ₹.8.00 lakh for Industries sector.
- ₹.8.00 lakh for Service sector.
- ₹.8.00 lakh for Business sector.

Subsidy in This Scheme

• Rate of subsidy on loan amount:

Documents Required with Application

- (1) Application Form (you can download in from website) in two set
- (2) Aadhar card/ Voter ID Card
- (3) Birth Certificate/School Leaving Certificate
- (4) Education Certificates/ Experience certificates
- (5) Quotation for the Instruments Which you want to Purchase
- (6) Proposed Place to do business (Rent Agreement/Vera Bill etc.)
- (7) Ration card
- (\mathcal{E}) Cast certificate (for SC/ST category)

Prime Minister Employment Generation Programme (PMEGP) By Central Govt.

- This scheme is implemented by Khadi and Village Industries Commission (KVIC) functioning as the nodal agency at the national level.
- At the state level, the scheme is implemented through State KVIC Directorates, State Khadi and Village Industries Boards (KVIBs), District Industries Centres (DICs) and banks.

Cont..

Who can apply?:

- Any individual, above 18 years of age.
- At least VIII standard pass for projects costing above Rs.10 lakh in the manufacturing sector and above Rs. 5 lakh in the business / service sector.
- Only new projects are considered for sanction under PMEGP.

Nature of assistance

The maximum cost of the project/unit admissible in manufacturing sector is ₹ 25 lakhs and in the business/service sector, it is ₹ 10 lakhs.


Ease of Doing Business, Gujarat
