In view of the strategy under New Industrial Policy, the Gujarat Government has introduced 'Scheme for Assistance for start-ups/ Innovation' vide its Resolution of Industries and Mines Department, No. MIS-102014-924909-I dated 27.01.2015. The Education Department (Higher and Technical), Government of Gujarat has published STUDENT STARTUP AND INNOVATION (SSIP) POLICY (2017-2021). A special focus under SSIP has been given on IPR protection and leveraging its impact.

The institute shall utilize the grant for students' start-ups for the following activities:

- a) Prototype support
- b) Patent support
- c) Activities, such as documentation, dissemination, creation of preincubation facility, conferences, hackathons, academic courses of start up and innovation, short-term training programmes, other pedagogical and academic interventions and other operational expenditure.

In this context, for the smooth functioning of SSIP activities at this institute, following Four SSIP Committees are framed. These committees are (1) Institute SSIP Committee (ISC) (2) IPR Scrutiny Committee and (3) Activity Wise Committee. (4) IPR Cell. Upon receiving an idea from students, the respective committee shall evaluate the idea to check whether the idea is feasible in the market or not. Once the idea is validated by the Department level SSIP committee (DSC) and Institute level SSIP committee (ISC), the students can avail financial support for proof of concept and prototype development. The students will also receive patent filing support if project/innovation is patentable approved by IPR Scrutiny committee.

The funds under the SSIP shall primarily be utilised for helping students producing a proof of concept, designing, filing patents and assist them on activities such as conducting workshops and programmes strictly in accordance with the financial guidelines provided under SSIP Project. The procedure for the receiving funds under SSIP is depicted in Appendix-1 with the flow chart.

All HODs must form department level SSIP committee for sensitization, scrutiny and echo system for smooth functioning and coordination at departmental level. Scrutinized proposals at the department level should be submitted to Institute level committee.
